- Starting soon: Cost Estimating Services to TetraTech on the Landsburg Facility Development Project for Seattle Public Utilities. SPU approved a Watershed and Transmission Facilities Master Plan, which recommends that SPU initiate capital improvements and buildings maintenance at its regional facilities, which are deteriorating and no longer meet operational requirements. The utility also provides public access to the Landsburg Park, a kayak course on the river and accessibility to a planned new hatchery scheduled to begin construction in late 2009 or early 2010. The property is registered as a Historic District on the National Register of Historic Places. We look forward to being a part of this worthwhile project!
